





# Problems in public works procurement

• The use of quotation rules which are out of date and/or have not updated since the date of adoption

Moldovan building regulations, codes of practice and rules of cost estimates in the field of "Construction Economics" are outdated and need to be updated

Discrepancy in the use of recommended amounts in the preparation of the estimate documentation by the contracting authorities and the economic operators' tender estimates





# Problems in public works procurement

1	DB16	Asphalt concrete asphalt concrete paving with small aggregates hot-mixed	Building material resource <b>Sand</b> bituminized and square steel lam. hot lt=30 mm is to be excluded as it is no longer used in the execution process In addition it is necessary to correct the consumption norm for Asphalt mix, as the current norm of 0.094 t/m <sup>2</sup> is insufficient.
2	DB19	Asphalt concrete asphalt mix with large aggregate, hot-mixed	Ibidem at item no. 1
3	DE17	Pavements made of precast concrete paving slabs placed on a layer of dry cement-sand mixture in a 1:3 ratio, mixed with cement and sand	It is necessary to introduce the consumption norm for the compactor plate machine, which is used in the paving process, but is not reflected in the costing norm.





# Issues in public works procurement

- Demonstration experience similar in within procedures of public procurement.
- ✓ Submission of the report on the completion of works, in which the conclusion of the National Inspectorate for Supervision Respectively a problem is outlined, whether it is necessary/mandatory to submit the minutes with the conclusion of the INST.
- ✓ Submission in procurement procedures of the final acceptance report/final report on completion of works
- ✓ Discretion of the contracting authority in interpreting the similarity of similar experience compared to the subject matter of the procurement





# Issues in public works procurement

- Tool third party supporter/subcontractor
- ✓ Given that the submission of tenders including a third party supporter is a fairly recent change, so far no there is a mechanism/instructions on the correct way to submitting bids with the help of the third party supporter.





# Problems in public works procurement

Inadequate preparation of tender documents and tender documentation documentation

✓ This problem implies an increased degree of difficulty when evaluating tenders and implementation contracts, being main cause for increase value contract via the appearance unforeseen additional works
